

TERMS AND CONDITIONS. NO PURCHASE NECESSARY TO PARTICIPATE IN THIS PROMOTION.

- 1. Promotion Timing:** The Mrs. Meyers Oopsurance Offer (the “**Promotion**”) begins at 12:00 am Eastern Time (“**ET**”) on March 31, 2025 and ends at 11:59 pm ET on April 30, 2025 (the “**Promotion Period**”).
